2. Eligibility

Those who make presentations of their research results at "international conferences on the EU", or those who will contribute to the development of research on the EU and Europe and to create a network among researchers. Applicants must be a full-time student of Kyushu University or an assistant professor or equivalent (including academic researchers, etc.) affiliated with Kyushu University under the age of 35 at the time of participation in the international conference. In addition, the applicant must present a paper at an international conference between 1 July 2023 and 15 September 2023. (*Limited to those that can be completed payment of this support fund by mid-September.) In the case of students, priority will be given to those enrolled on the EU Study Diploma Programmes (EU-DPs) in the event that there are too many applicants for the grant.

7. Payment of Support Funds

After confirmation of participation in the conference, the support is transferred to the beneficiary's own bank account, etc., as specified by the beneficiary. In the following cases, the support shall be refunded even after the payment has been made.

- (i) When the scheduled international conference does not take place.
- (ii) When an entry is made but not accepted.
- (iii) When the project was accepted but could not be reported.
